This document is published in accordance with the provisions of Rule 3 (1) of the Information Technology (Intermediaries guidelines) Rules, 2011.

The Constructionwale.com Seller Community is operated by Constructionwale.com (Karma Yoga Vedanta Private Limited, a company incorporated under the Companies Act, 1956 with its registered office at 8 Bhumi Mall sector 15 Palm Beach Road CBD Belapur Navi Mumbai, India (hereinafter referred to as "Constructionwale.com").

By merely accessing the Constructionwale.com Seller Community, You shall be deemed to have contracted with Constructionwale.com and have agreed to be bound by the terms and conditions herein contained, including the various policies incorporated by reference in this Agreement.

If You post on or otherwise access the Constructionwale.com Seller Community, You shall be subject to these guidelines..

For the purpose of these Terms of Use, wherever the context so requires "You" or "User" shall mean any natural or legal person who has registered as a Seller on the Constructionwale.com Website or App. The term "We", "Us", "Our" shall mean Constructionwale.com .

By impliedly or expressly accepting these Terms of Use, You also accept and agree to be bound by Constructionwale.com Policies ((including but not limited to Privacy Policy) as amended from time to time.

1. Constructionwale.com Seller Community- Purpose :

The Constructionwale.com Seller Community provides a platform for Constructionwale.com sellers to exchange ideas, knowledge, and opinions about anything related to selling on Constructionwale.com, both on the website and the App. Constructionwale.com has created these Terms of Use for the purpose of encouraging

and maintaining an enjoyable and safer environment in the Seller Community where there can be open and honest communication among all members.

2. Eligibility for Participation

At this time, the use of the Seller Community is limited to users with a Constructionwale.com seller account. Please bear in mind that your use of the Seller Community is subject to the terms of the Constructionwale.com Privacy Policy, Terms of Use and your seller agreement which are included herein by way of reference.

3. Adherence to Community guidelines

We encourage you to use the Seller Community to share your ideas, knowledge, and opinions with other sellers. While we appreciate your comments, we do require that you follow the general posting guidelines listed below. Violation of these guidelines may subject you to a range of actions, including removal of posts or other content, temporary or permanent access to our community areas, limits on your selling privileges, and suspension of your account.

4. General Posting Guidelines

- a. Your posts should focus on topics specific and relevant to the Seller community and the respective thread.
- b. Post on the community with the intent of sharing your ideas, knowledge, and opinions about a specific issue
- c. You may share and exchange ideas pertaining to growth of your business in general, even if such ideas are unrelated to selling on the platforms provided by Constructionwale.com
- d. Feel free to put forth questions to your peers.
- e. Share your ideas, recommendations for improving the all-round experience on the Constructionwale.com platform
- f. Give us honest feedback about the things at which we are succeeding, and constructive criticism about those which can be improved.
- g. Posts should respect the privacy of all Constructionwale.com members and should be courteous towards members, opinions, and initiatives.
- h. Advertising:
 - I. You can generally advertise a Constructionwale.com product listing that is directly related in benefiting a community project, but you can't post the item number or a link to the listing.
 - II. The ad must directly relate to the community project, and can only be mentioned once per thread

5. Prohibited Content:

You shall not post any content which:

- a. belongs to another person and over which you have no right;
- b. is grossly harmful, harassing, blasphemous, defamatory, obscene, pornographic, pedophilic, libelous, invasive of another's privacy, hateful, or racially, ethnically objectionable, disparaging, relating to or encouraging money laundering or gambling, or otherwise unlawful in any manner whatever, or unlawfully threatening or harassing, including but not limited to 'indecent representation of women' within the meaning of the Indecent Representation of Women (Prohibition) Act, 1986;
- c. is misleading in any way;
- d. is patently offensive to the online community, such as sexually explicit content or content that promotes obscenity, pedophilia, racism, bigotry, hatred, or physical harm of any kind against any group or individual;
- e. harasses or advocates harassment of another person;
- f. involves the transmission of 'junk mail', 'chain letters', unsolicited mass mailing, or 'spamming';
- g. promotes illegal activity or conduct that is abusive, threatening, obscene, defamatory, or libelous;
- h. infringes upon or violates any third party's rights [including but not limited to intellectual property rights, rights of privacy (including without limitation unauthorized disclosure of a person's name, email address, physical address, or phone number) or rights of publicity];
- i. promotes an illegal or unauthorized copy of another person's copyrighted work (see 'Copyright complaint' below for instructions on how to lodge a complaint about uploaded copyrighted material) such as providing pirated computer programs or links, information to circumvent manufacturer-installed copy-protect devices, or pirated music or links to pirated music files;
- j. contains restricted or password-only access pages, hidden pages or images (those not linked to or from another accessible page);
- k. provides material that exploits people in a sexual, violent or otherwise inappropriate manner or solicits personal information from anyone;
- l. provides instructional information about illegal activities such as making or buying illegal weapons, violating someone's privacy, providing or creating computer viruses;
- m. contains videos, photographs or images of another person (with a minor or an adult);
- n. tries to gain unauthorized access or exceeds the scope of authorized access to any platform operated/provided by Constructionwale.com or solicits passwords or personal identifying information for commercial or unlawful purposes from other users of any platform operated/provided by Constructionwale.com;
- o. engages in commercial activities and/or sales such as contests, sweepstakes, barter, advertising, pyramid schemes, or the buying or selling of 'virtual' items related to any platform operated/provided by

Constructionwale.com without our prior written consent. Constructionwale.com's prior written consent means a communication coming from the Constructionwale.com's Legal Department in response to your request and specifically addressing the activities or conduct for which you have sought authorization; (p) solicits gambling or engages in any gambling activity which we, at our sole discretion, believe is or could be construed as being illegal;

- p. interferes with another's use and enjoyment any platform operated/provided by Constructionwale.com;

- v. any content that directly or indirectly, offers or attempts to offer trade or attempts to trade in any item which is prohibited or restricted in any manner under the provisions of any applicable law, rule, regulation or guideline for the time being in force;
- w. any content that creates liability for us or cause us to lose (in whole or part) the services of our Internet Service Provider ("ISPs") or other suppliers.

6. Language:

Any use of the following kind of language is unacceptable of the Seller Community:

- a. Vulgarity
- b. Hate or racist speech
- c. Disruptive or hostile comments
- d. Threats of violence
- e. Interpersonal disputes
- f. Offensive language in user IDs
